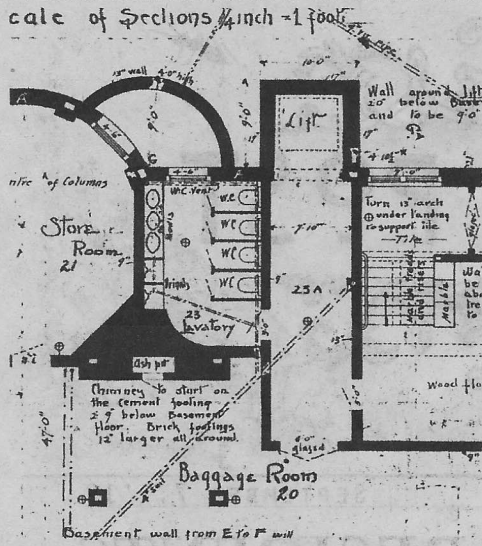

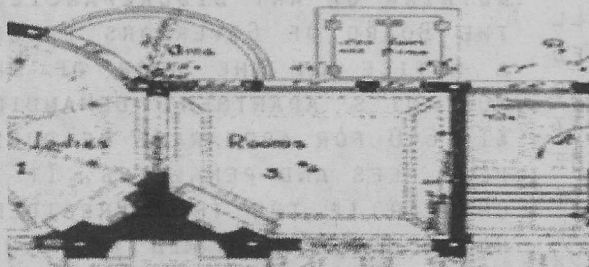
# CASTLE GREEN RESIDENTS IN CASE LAW

TODAY, WHEN YOU PASS THE CLOSED IRON DOORS TO YOUR LEFT ON YOUR WAY TOWARDS THE AUTOMATIC BACK GATE YOU WILL SEE WHERE THERE WAS ONCE, IN 1900, A BAGGAGE LIFT THAT LOWERED LARGE TRUNKS DOWN TO THE BASEMENT BAGGAGE ROOM. WHEN IN THE BASEMENT GOING TOWARDS THE MEN'S ROOM BUT NOT ENTERING, ON THE RIGHT ARE TWO GLASS DOORS CLOSING OFF A STAIRWAY WHERE THE LIFT ONCE EXISTED. THE DRAWING BELOW IS THE SAME SPOT SEEN FROM THE 1ST FLOOR ELEVATION SHOWING THE HEAVY IRON DOORS OUTSIDE THAT THE NEWSPAPER HAD MENTIONED. NOTE: THE TURKISH AND MOORISH ROOMS ARE LABELED "LADIES ROOMS." SORRY, SO BLURRY-EYED NOW.
